The object of the examination meets the established medical criteria for safety:

General specifications DTSU 2.2.9.027-99" State sanitary and safety standards for products of the perfume and cosmetic industry, Regulation (EU) № 1223/2009 of the European Parliament and Council of November 30, 2009, for cosmetic products based on the results of identification, assessment of the risk to public health, as well as the results of verification (control) of the object of examination provided by the applicant, namely the index of adverse effects on the skin of people INI 0 points. Microbiological parameters: MAFAM, CFU in 1 cm³ not more than 1000; Enterobacteriaceae in 1 g is not allowed; S. Aureus is not allowed in 1 g; B Pseudomonas aeruginosa is not allowed in 1 g; yeast and molds CFU in 1 g of not more than 100.

Require conditions for use, storage, transportation, disposal, and storage:

- a) Compliance with the requirements established by this opinion based on the test of the specimen submitted;
- b) ensuring the conditions of transportation and storage of products in accordance with the manufacturer's recommendations set out in the accompanying documentation;
- c) annual testing of the object of examination for compliance with the requirements of this opinion and the current sanitary legislation.

According to the results of the state sanitary and epidemiological examination Creams and skin

care products are made in accordance with DSTU 4765: 2007 "Cosmetic balms. General specifications" in the range according to the appendix to the conclusion, according to the applicant, the sample meets the requirements of the current sanitary legislation of Ukraine and, subject to the requirements of this opinion, can be used in the stated scope.
